Service System

There are also a couple of different introductions to that frame, one to regions that are talking about reunifying or sharing services, and another to communities that were asked to become part of a "core group" of field testers. Traditions Book Project

As you may know, the 2012 World Service Conference approved a project plan for starting work on a Traditions book. The project plan was developed in response to a motion at WSC 2010 and the results of the 2011 Fellowshipwide literature survey, which identified a Traditions book as a priority literature project.

The Tradition Book Project focus for the 2012–2014 conference cycle will be to gather ideas and source material for the book and work toward identifying Fellowship consensus about what the book should look like.

3. Traditions Book Project discussion board to be launched in early 2013

IX CRCNA UPDATE

Greetings Colorado Region!

Thank you everyone for showing up and making CRCNA 26 a roaring success!

Most everything was seamless; there were really only two big issues we ended up dealing with. The first regarded the play. About 3 months before the convention, we received notice that Mile High H&I wanted to do an H&I play. Over the next few months we did what we could to accommodate it, including finding a time to schedule it, getting rooms for rehearsal and organization, and all the associated media equipment. Less than two weeks before CRCNA we received an email that the play had been cancelled. This was after all the programs were printed and arrangements finalized. I do not know all the details of what happened (although I have heard several versions), but there were numerous players involved, with no shortage of internal bickering, and at the 11th hour someone else stepped up and took it over, so I extend my appreciation to that individual. I also offer my apologies to those who felt their toes had been stepped on during this somewhat messy situation.

The other issue was in regard to the Sunday morning speaker. The Wednesday before the convention, our Program Chair sent an email to the speakers making sure they have everything they needed, and she received a response from the Sunday Speaker that he had been having some medical issues and could not make it. We were very fortunate that there was an out of town visitor already attending who had some experience with being a Sunday Morning Speaker and she agreed to step up. We are presently working with the original speaker to have him refund his airline ticket money so we can pay the ticket for the individual who did speak.

We registered approximately 843 people – 238 H&I, 539 paid, and 66 newcomer. As is usually the case, there were certainly more than 843 people there.

We sold all our apparel except for 3 sweatshirts. We only sold half our mugs however, and there are some 150 mugs in the storage unit. This amounts to approximately \$600.

In regard to money, at this point we believe we will be donating approximately \$9,000 to the Region. We just received our bill from the hotel, and we believe it to be high. Our H&H Chair is presently negotiating with the hotel. We intend to have the exact figure before the next Region.

XI WSLD XXVI REPORT

Colorado Region's hosting of WSLD 26 held on Oct 12-14, 2012 was a resounding success on so many levels!! Below we have shared just a few.... We are pleased to share how Colorado addicts showcased service provision in our Region... As you know, any WSLD conference is guided by the WSLD Steering Committee. At the final board (5 hours on Sunday after end of conference) meeting of this group, comments ranged from "excellent" to "best ever"... We did it!! (Note: As Chair of WSLD 26, I become an ex-officio member of this Committee for at least one year or for as long as I choose to participate... I will keep you posted!) The few negative comments centered on problems that were hotel based (delay in food delivery – not enough staff for our needs and 2 room keys that kept failing to work... nothing big). In addition, one addict (out of 23 attendees) thought our program was not diversified enough (i.e. nothing on phone lines). XV ARCHIVE AD-HOC PRESENTATION

Dave R. presented information about the proposed Regional Archive, including the Archivist Resource position and a proposed budget. (See Appendix D for budget information.)

Article 6: Resource Position

Standing resource positions are established to assist the areas of the region and are appointed by the CRSCNA. Members who are appointed a resource position will be given "resource assignments" as directed by the CRSCNA. They will maintain contact with the World Service Office for the latest information and resources about their particular field of service.

Section A: Literature Resource

Section B: Archive Resource

The addict filling this position needs the following skills and/or knowledge:

- Has organizational and archival experience
- Has the ability to thoroughly understand what does or does not have archival importance
- Has experience at the Regional Service level within last 5 years
- Has working knowledge of how to store, manipulate, and display digital assets.
- Has the ability to handle both physical and digital archive materials

Responsibilities:

- Inventory, organize, and maintain archival records.
 - Inventory currently held archive materials.
 - Scan physical archive items for digital storage.
 - Maintain digital archive storage.
 - Intake of donated items.
 - Seeks Resources from the fellowship as necessary to complete the tasks necessary for the Resource Position

- Supervise service pool workers who assist in arranging, cataloging, exhibiting, and maintaining regional archive materials.
 - Research and record the origin and historical significance of archival materials.
 - Utilize proper techniques to preserve records, documents and objects.
- Develop system to facilitate access to archival materials.
 - Display archive items where appropriate
 - Be the single point of accountability for archived assets.
 - Serves as a resource to areas for storage of area archive materials.
 - Serves as a resource to regional event committees for storage of regional event archive materials.
 - Develops dynamic guidelines for archive resource position to include acquisition of items, what is stored, and how it is stored and display.
 - Close working relationship with Regional Web Servant
 - Adheres to Internal Archive Guidelines
 - Clean Time Requirement - 12 years

Discussion Points:

- The group discussed requirements and candidates for appointment to the Archivist resource position
- There will be a number of key historical documents scanned and available via the website; discussions with Mike H. (Web servant) are in progress to confirm storage and display capabilities. Tawni C. noted that a new Region website is in development and these requirements will be taken into consideration.
- The term of the position will be 2 years.
- Sheila M. is interested in the position and has skills in archival and electronic inventory tools; she qualified herself and was approved.
- Dave R. presented options for storage in a climate-controlled facility, with costs starting at \$770 per year.
- The question was raised whether the CRCNA storage unit should be moved to be covered by the CRCNA budget going forward. (See proposal in New Business section)
- It was suggested and agreed that this should be taken back to the Areas for discussion and input prior to committing to the expense.

XVI BUDGET AD-HOC PRESENTATION

On November 3rd our budget Ad-hoc met and we had the best turn out yet! We discussed our current budget structure and revision recommendations to the budget that was proposed by the Sean at the September regional meeting. We discussed the original goals of the Ad-hoc such as the need for a prudent reserve, budget flexibility, quarterly or tri annually budgeting, encumbered funds, tier 1 definition, a possible automatic percentage donation to world from CRCNA's generated funds, RCM travel reimbursement, and more. We never got off topic..... Just joking! Many views were voiced and I believe it to have been a very productive meeting. Some members would like to ratify the budget as it was purposed in September to simplify some language that is difficult to understand in the hopes that the implementation will be easier. Before the next Ad-hoc meeting that is scheduled for January 12th we are going to bring both the revised and non revised budgets to the various areas within our region to affirm that we are truly acting on behalf of the fellowship we represent, and that we are moving in the right direction. We hope to consolidate the new budget at our January 12th Ad-hoc meeting and have a clear concessive proposal to bring to this body. I am sure that I left something out but I failed to assign a secretary to keep notes during our discussion and I was freezing during the outdoor meeting. Thank you to all that showed up to the meeting I really feel that I have so much to learn and I am graced to have such wonderful people to teach me.

XVII ELECTIONS

- CRCNA XXVII Chair: Alan H. and Kurt B. were nominated, and qualified. Kurt B. withdrew his acceptance of the nomination, and Alan H. was **Elected**
- CRCNA XXVII Vice Chair: Brandi J. was nominated, qualified, and **Elected**
- CRCNA XXVII Secretary: Stephanni C. volunteered, qualified, and **Elected**
- CRCNA XXVII Treasurer: **OPEN**
- CRRMCO Chair: Anna H. was nominated, qualified, and **Elected**
- CRRMCO Vice Chair: **OPEN**
- CRRMCO Secretary: **OPEN**
- Regional Delegate Alternate (RDA): Jayme S. was nominated, qualified, and **Elected**
- PI Chair: **OPEN**

Discussion Points:

- Kurt was asked about his ability and willingness to travel as needed, given that CRCNA 27 will be located in the Mountains West area. He responded that he is willing to travel, and noted that he expects to move the CRCNA planning meetings to a location further north in the greater metro area in order to make it more convenient for people to attend from various areas within Colorado.
- Both nominees were asked about willingness to involve speakers and participants from other areas (not just the “home” area where the Chair is located or where the event is held); both nominees responded with information about past attempts to involve members from other areas and challenges encountered.
- One attendee noted that it was an unusual situation to have someone other than the current Vice Chair nominated for this position. He stated that there’s been discussion about the climate and direction of recent CRCNA events, and that he’s been made aware of some concerns that haven’t been raised during this meeting, but have driven the step of nominating someone other than the Vice Chair. The group asked for details about any issues related to the CRCNA 26 administrative committee and Kurt’s service as Vice Chair.
 - One attendee stated that she was very disappointed by several aspects of CRCNA 26, including:
 - lack of response from the committee members to her statements of concern prior to the event
 - poor selection of speakers based on friendship rather than tapes and qualifications
 - “party” culture rather than respectful celebration of clean time
 - balls thrown during clean time countdown, which created an environment that caused an injury to her and made some of her sponsees uncomfortable
 - One attendee noted that the only issue she’s heard about was Kurt’s lack of attendance at Region meetings.
 - Another attendee pointed out that he can only go by the Concepts, and the fact that Kurt didn’t attend Region is a violation of those concepts. This is the same behavior that led to recent problems with the original WSLD 26 Chair.
 - Kurt stated that he’s missed a few meetings, and that he doesn’t feel he needs to be in the meeting all day so he leaves early but he’s been in several Region meetings.
 - Another attendee stated that these issues should have been brought up during the CRCNA report section of the meeting, and that this had the appearance of being an attack.
 - The CRCNA 26 Chair stated that the programs were approved by the CRSC, and that he had not received any complaints about the Committee. He suggested that if people want a say in how CRCNA is run they should come to the CRCNA meetings.
 - The acting CRSC Chair pointed out that the focus of the discussion should be questions for the nominees. He suggested that the group proceed with the election and wait to discuss concerns about CRCNA 26 until the Proposals section of the agenda.
 - One attendee disagreed with this suggestion and noted that she is concerned about Kurt’s lack of attendance and unwillingness to stay for the entire Region meeting, and about him using his phone throughout the meeting today. She also stated her opinion that attendees having sidebar conversations during the Q&A portion of the election process is inappropriate. She does not agree that addicts should have to show up at a CRCNA meeting to be heard. It is her understanding that CRCNA is accountable to this body (Region), and Region is accountable to the members of the fellowship.

- Another attendee asked Kurt whether he was willing to uphold the guidelines. At this point, Kurt stated that he felt the fellowship could best be served if he withdrew his acceptance of the nomination, and that he did not want to be considered as a candidate for the CRCNA 27 Chair position.
- Elections proceeded at this time without further discussion of issues related to CRCNA 26.

XV OPEN DISCUSSION

- The acting Chair appointed Anna H. to ad-hoc position to review CRCNA guidelines and recommend changes based on today's proposals and also on other issues.
- Regional PR will take leftover WSLD literature items donated by NAWS
 - o Leftover merchandise will be taken to the storage unit
 - o \$180 designated as WSLD Newcomer Donations will be donated to CRCNA
- One attendee asked what steps we as a body should take to unify after what happened today,
 - o It was suggested that it's essential for us to encourage members of the fellowship to get involved in CRCNA, and in Regional activities as a whole, rather than turning to gossip
- One member asked whether there is an appropriate process is for the CRSC committee to give feedback to the CRCNA committee after the annual event has occurred. This is important information to be communicated to those who may be nominated/elected for CRCNA positions in the coming year.
 - o It was noted that the term of the CRCNA committee members lasts until January of the following year, when they present their final financial report.
 - o Another attendee agreed that this overlap period between elections in November and final meeting in January was extremely valuable to him when he served on a regional convention committee.
 - o A suggestion was made that this could be formalized in some way by conducting an annual CRCNA inventory
 - o One attendee pointed out that in the past there was an evaluation form included in the materials handed out at CRCNA, and this provided a basis for discussion of successes, challenges, and potential changes.
- In relation to the agenda, the acting Chair asked for feedback on how the order and content could be improved in the future.
- One attendee commented that he felt the group dealt with difficult issues during this meeting in a way that followed the NA traditions.
- The Secretary asked for the group's conscience on whether it would be appropriate to follow the process that has been used previously when sensitive personal issues about individual members were dealt with in the meeting. In that situation, all conversations and information that are captured during the meeting are forwarded to the Chair and Vice Chair, and they provide guidance regarding the final content of the Minutes. The group agreed that this is the correct course of action for today's meeting.
